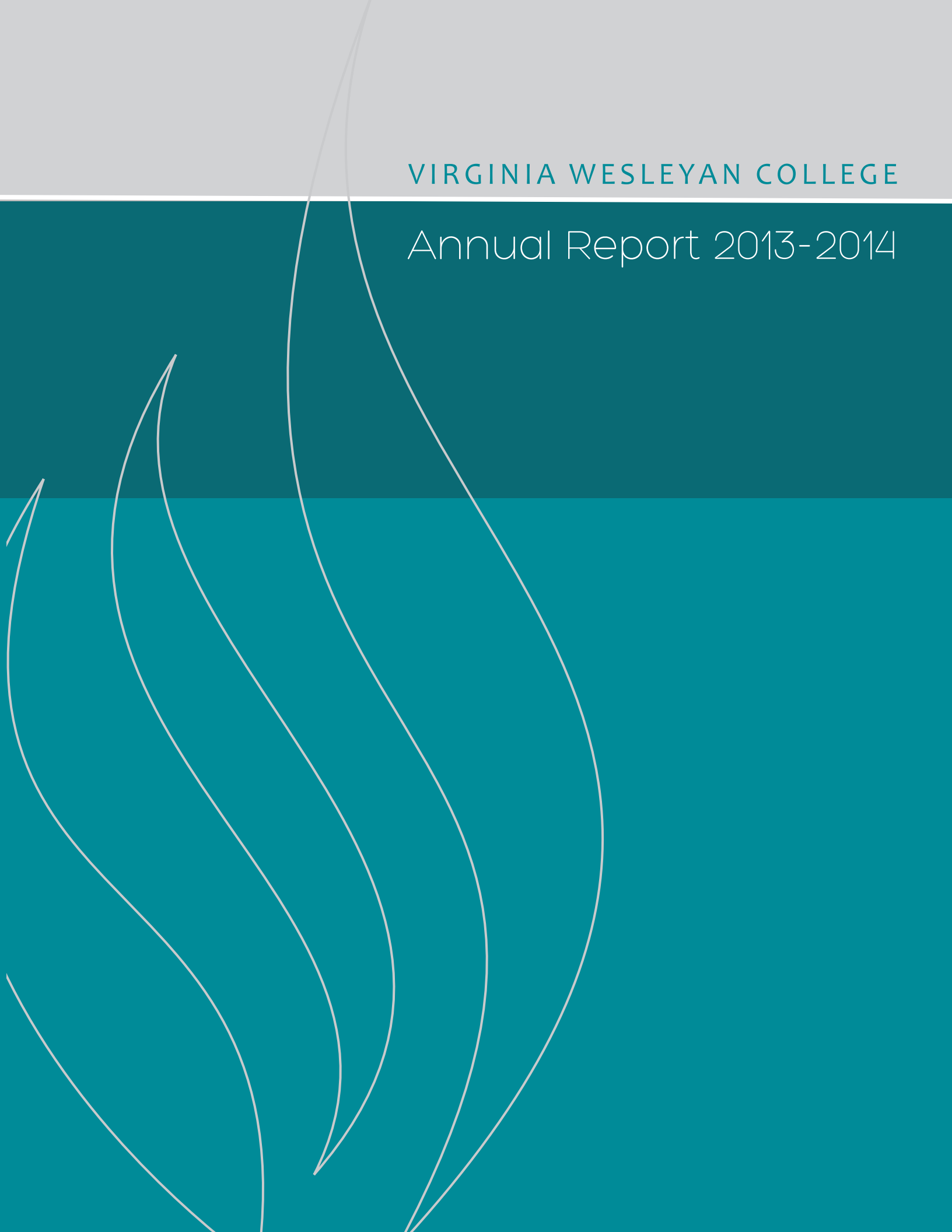
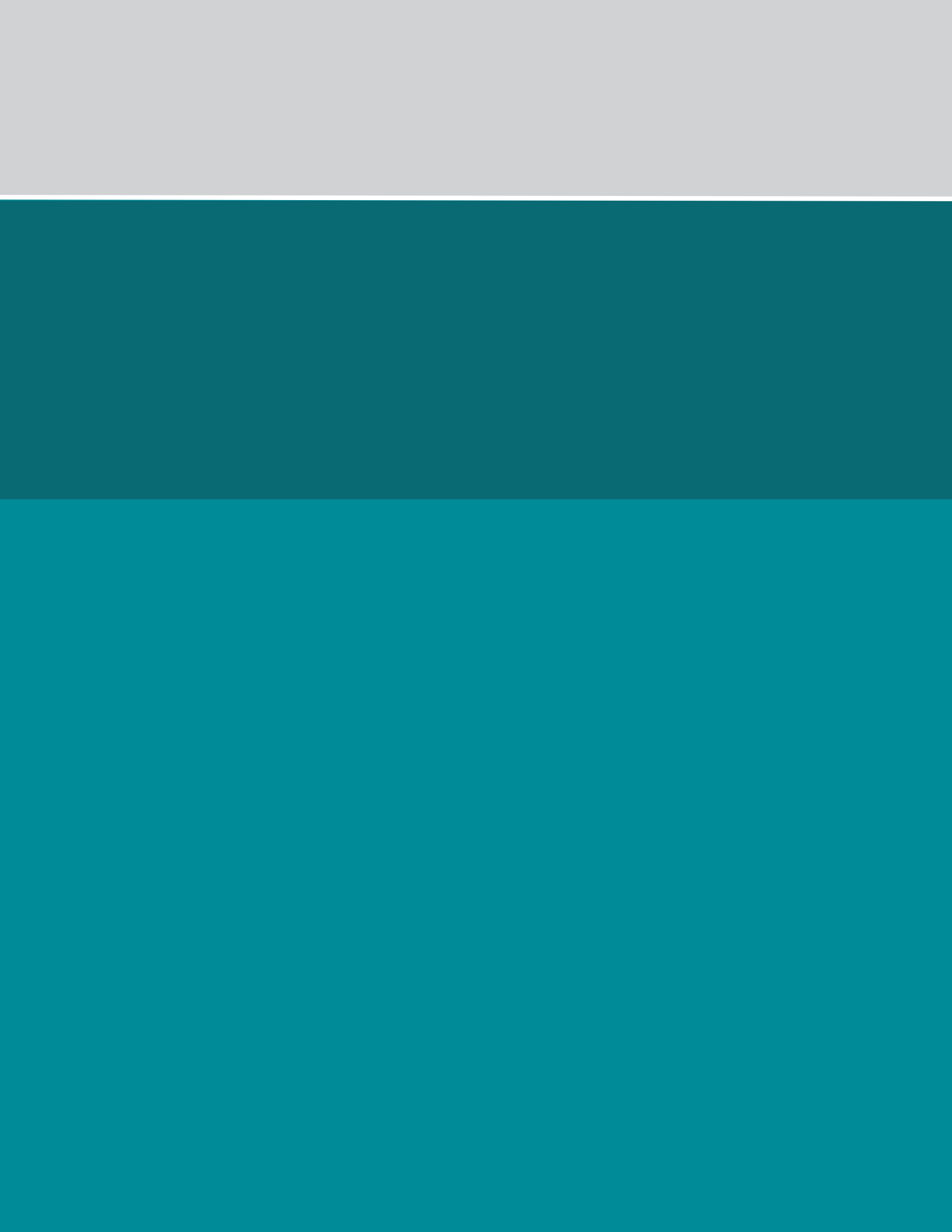

**Dear Virginia Wesleyan Community and Friends,**

It is with great pride that I share the Virginia Wesleyan College Annual Report for the 2013-2014 fiscal year. As the College celebrates a year of successes and important milestones, we are actively engaged in our mission of preparing each student for a meaningful life and career while embracing our core values of academic excellence, supportive community, religious freedom, ethical conduct and social responsibility.

These values are articulated along with a primary goal, five strategic priorities and 20 key actions in the College's recently unveiled strategic plan, *VWC 2020: Pathway to Prominence*. On May 21, 2014, the Board of Trustees approved the plan that provides a path for growth and positive change for the College. It is the result of a two-year collaborative process that involved broad-based stakeholder input from students, alumni, faculty, staff, Board and community members. Implementation of the plan commenced in fall 2014.

At the start of the 2013-2014 academic year we welcomed the Class of 2017, the largest and most qualified class in the College's history with an average SAT score of 1024 and a combined high school GPA of 3.33. The new student group represents 23 states, includes more than 20 bilingual students and contains multiple valedictorians and salutatorians and those who have achieved success in extracurricular activities and community service.

In spring 2014, a Virginia Wesleyan choir made up of approximately 50 singers traveled to New York City to perform at the legendary Carnegie Hall, a first for the College. You will find that and many other highlights of the past year in this report. I hope you enjoy learning about our points of pride, both academic and athletic—from being named among the top tier of National Liberal Arts Colleges by *U.S. News and World Report* to our three Old Dominion Athletic Conference Championship wins. You'll also read about renovations to Blocker Hall Auditorium and the Floyd E. Kellam Jr. Social Science Lab; a \$30,000 grant from the Dominion Foundation; the new agreement with Norfolk-based NATO-ACT; a generous challenge gift from the Birdsong Corporation and George and Sue Birdsong for a new synthetic turf field; and more.

As you may know, in May 2014 I announced to our Board of Trustees that I would be retiring as president of the College on June 30, 2015. My 23 years at Virginia Wesleyan are among the best of my career and I have been very proud to be a part of this College community. I would like to express my profound gratitude for the support and guidance I have received over the years, especially for the continued generosity of our alumni, parents, donors and friends on behalf of the mission of this institution: the "life-changing business" that happens every day in our classrooms, communities and around the world. ## A Better Blocker

VWC's natural sciences building, Blocker Hall, received more than a half million dollars in renovations in summer 2014.

A generous donation made by S. Frank Blocker Jr. funded construction of a newly landscaped entryway overlooking Smith Drive along with the creation of a foyer and reception area. The donation also allowed for the auditorium to be modernized with new seating, flooring and ceiling, and improved lighting and HVAC systems. Both areas were made more handicap accessible, benefiting students like Elizabeth Sims '16, who uses a wheelchair.

"I am overwhelmed with gratitude to Mr. Blocker, who made these renovations possible," she said. "They help show current and future students, parents, faculty, and friends just how inclusive and welcoming we, as Marlins, strive to be."

Gifts from Nick and Judy Maravich, Dr. Angela Mercer and Reginald Corinaldi provided funding for the renovation of Blocker 103 into a Molecular Cell Biology Lab and Blocker 230 into a Microtome

Lab. The former office and storage spaces were transformed into project labs, providing resources for up to five undergraduate research projects per semester.

## VWC's Economic Impact

In his 2013 State of the College Address, VWC President Billy Greer shared the exciting findings of a study done by Dr. James Koch, Board of Visitors Professor of Economics at Old Dominion University, on the economic impact of Virginia Wesleyan College on the Hampton Roads region of Virginia. The study, which characterized VWC as a "large economic enterprise," found that the College's overall contribution to the local economy totaled \$376.13 million. This figure factored in the spending and ripple effects of Virginia Wesleyan's 290 full-time and 96 part-time employees, approximately 1,400 students and 4,000 area alumni. Along with the College's numerous intellectual and cultural contributions to the community, the study underlines the institution's financial significance in the region's seven largest cities.

## Agreement Benefits NATO-ACT Dependents

Virginia Wesleyan entered into its first-ever formal agreement with North Atlantic Treaty Organization-Allied Command Transformation (NATO-ACT) in June 2013, offering up to 25 International Student Grants of \$9,000 per semester (\$18,000 per year) to dependents of NATO-ACT employees stationed in Norfolk. VWC President Billy Greer and NATO-ACT Chief of Staff Vice Admiral Charles Anthony "Tony" Johnstone-Burt, CB, OBE, signed a "Letter of Accord" at an on-campus ceremony held on June 7.

In exchange for the scholarships offered under the new agreement, NATO-ACT provides its staff's expertise to the VWC community in the form of guest lectures, internship opportunities, and events like the 2014 Model NATO Challenge. VWC had the honor of serving as the meeting place for the mock global crisis simulation in March 2014. Both organizations continue to work hand-in-hand to provide mutually beneficial experiences for their respective constituencies.

### Birdsongs make generous \$1 million challenge gift for synthetic turf field

A \$1 million challenge gift was made in January 2014 by the Birdsong Corporation and George and Sue Birdsong to be put toward the installation of a synthetic turf field at VWC's Outdoor Athletic Complex.

"The Birdsongs have provided tremendous leadership to the College by supporting some of our most important initiatives," said Virginia Wesleyan President Billy Greer. "This enormously generous gift will support more than 150 student-athletes playing men's and women's lacrosse and field hockey and will support all of our students who desire to play a variety of intramural sports."

The NCAA Division III athletics programs at VWC are a vital part of the college experience for the student-athletes who represent nearly 30 percent of the student population. This new synthetic turf field will provide a state-of-the-art

venue for training and hosting athletic competitions.

In the same spirit of competitiveness and teamwork so vital to successful athletics, the Birdsongs' contribution was offered as a one-to-one challenge gift. Other donors are challenged to make additional contributions totaling \$1 million for this premier outdoor athletic facility by December 31, 2015.

Like the recent gift from the Goode family for a new academic building for the arts, this gift came at a time when VWC was immersed in a strategic planning process that is now setting the direction for the future of the College. The arts building, formally named Goode Hall, and the Outdoor Athletic Complex will bring a greater sense of arrival and presence to the entrance of the College and will address the overall modernization and beautification of the campus.

## Modernization Complete of the Floyd E. Kellam Jr. Social Science Lab

Modernization of the Floyd E. Kellam Jr. Social Science Lab in Residential Village II was completed in summer 2014. Private support for the project was leveraged by a generous \$250,000 challenge grant made by The Cabell Foundation that required matching funding on a two-to-one basis.

The new lab, which cost approximately \$750,000 total, provides a modern space for cross-disciplinary research among the Social Science Division and promotes expanded opportunities for undergraduate research.

Updates include versatile classroom space for group work, discussion and speakers; a functional layout appropriate for a variety of simultaneous uses; an expanded computer lab with upgraded systems; and interview and observation rooms.

The latter offers privacy for confidential interviews, opportunities for hands-on practice, behavioral experiments and more.



Modernization coincided with the introduction of the College's new Bachelor of Social Work degree, which saw its first graduates in May 2014. The new degree and the renovated lab provide the direction and facilities needed to fully engage students and set a foundation for excellence in course work and future careers.

# Virginia Wesleyan Makes its Carnegie Hall Debut

Forty-nine members of the Virginia Wesleyan Chorale and Wesleyan Singers –plus a handful of faculty and students from Tidewater Community College and the Hampton Roads community–traveled to New York City over Memorial Day Weekend 2014 for two Carnegie Hall performances that made up “The Voices of Virginia Wesleyan College.” The concert represented the culmination of a long journey for both the students and Virginia Wesleyan, which celebrated its own Carnegie Hall debut along with them.

trip, providing an opportunity for students to take their music out of the classroom and into the world.

“Taking part in choral music, whether as an audience member, singer, conductor or composer, is an opportunity to slow down time long enough to allow the beauty of life to catch up with you,” says Trotta.

Combined with an orchestra and four other choirs from around the country, the group performed Mozart's Requiem, directed by internationally renowned composer John Rutter. And prior to that, the Virginia Wesleyan choir had a chance to shine solo as they opened the concert with original

compositions by Trotta, entitled “Music of Stillness, Peace, and Hope.”

This monumental moment came at an exciting time for VWC's Music Department. Plans for the construction of a new academic building devoted to the arts are underway at the College, stimulated by an initial \$5 million challenge gift made in 2013 by Susan and David Goode, their daughters Christina and Martha, and their son-in-law Blair Mielnik.

The building is being designed by architects Tymoff + Moss with input from students, faculty, staff, and friends of Virginia Wesleyan. The facility is envisioned as a gathering place for both

the College and the larger community, and in addition to stage productions it will be used for lectures, film showings and as a meeting place for individual classes and larger groups. Scope of the building and a timeline for construction will be determined as fundraising progresses.

In recognition of the Goode family's commitment to the arts and dedication to the College, VWC's Board of Trustees voted to name the new facility Goode Hall. It will be situated on a rise of land across from the College's entrance, serving as a welcoming beacon for all arriving on campus.

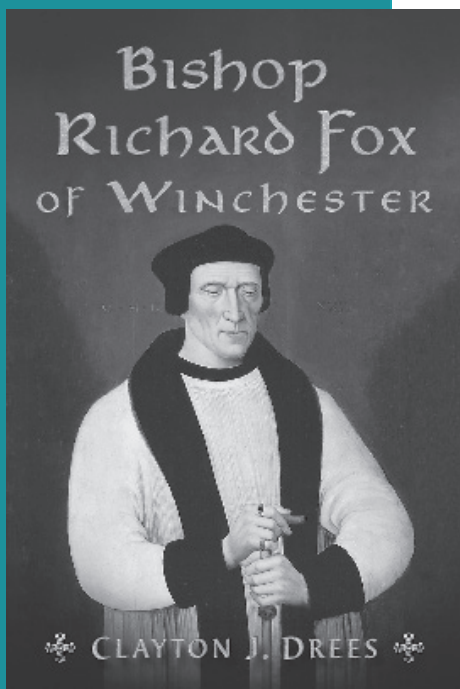

**Assistant Professor of Chemistry Maury Howard and Professor of Biology Maynard Schaus** were awarded a \$30,000 Dominion Higher Education Partnership Grant in August 2013 for their project entitled “Habitat Improvement and Water Quality Monitoring in Urban Storm-water Management Ponds.” The grant was used during the 2013-2014 academic year primarily for undergraduate research involving measurement and monitoring of water quality and biota in storm water management ponds that have been planted with emergent, submerged and shoreline vegetation.



**Professor of Philosophy Steven Emmanuel** was awarded the 2014 **Maurice L. Mednick Memorial Fellowship** by the Virginia Foundation for Independent Colleges (VFIC). The \$2,000 grant supported his summer 2014 travel to Kyoto, Japan to conduct field research for a paper entitled “**Zen Buddhism and Japanese Martial Tradition.**” Emmanuel is the author of *Kierkegaard and the Concept of Revelation* (State University of New York Press, 1995) and most recently served as editor of several volumes for publisher Wiley-Blackwell, including *A Companion to Buddhist Philosophy* (2013).

**Associate Professor of French Alain Gabon** published “Egypt: The 5 Reasons of the Coup” in *Saphirnews* in August 2013; and “Is Islamophobia Losing Ground in France?” in *Les Cahiers de l'Islam* in November 2013 in addition to numerous other articles on international news and opinion websites.

**Professor of History Clay Drees** completed work on his book *Bishop Richard Fox of Winchester: Architect of the Tudor Age* (McFarland and Company, 2014) and **Professor of Political Science Bill Gibson** co-authored *The Case for Grassroots Collaboration: Social Capital and Ecosystem Restoration at the Local Level* (Lexington Books, 2013).

**Assistant Professor of Political Science Aubrey Westfall**, in addition to her work with VWC's Model UN team, co-taught “Unconventional Leadership” in spring 2014 with Colonel Imre Porkolab, National Liaison Representative of the Hungarian Defense Forces in the United States, NATO. Westfall also completed data collection in December 2013 for one of the largest surveys of Muslim-American women ever conducted in the United States.

In support of her research, the VFIC awarded Westfall with the **Maurice L. Mednick Memorial grant** in April 2013. The \$2,000 fellowship helped fund some of the 30 focus groups held nationwide as part of her project: “Veil and the Voice: Muslim American Women and the Decision to Veil.”

**Assistant Professor of History Kathleen Casey** and a multidisciplinary faculty team made up of **Associate Professor of History Richard Bond**, **Assistant Professor of Criminal Justice and Sociology Thomas Brown**, **Associate Professor of Management/Business/Economics Paul Ewell**, and **Assistant Professor of English Kellie Holzer** have been selected for 2014 **Innovative Teaching and Engaged Learning (INTEL)** grants. This is the second year the grants have been awarded, providing up to \$1,000 for projects that encourage and advance a culture of innovation and engaged learning.

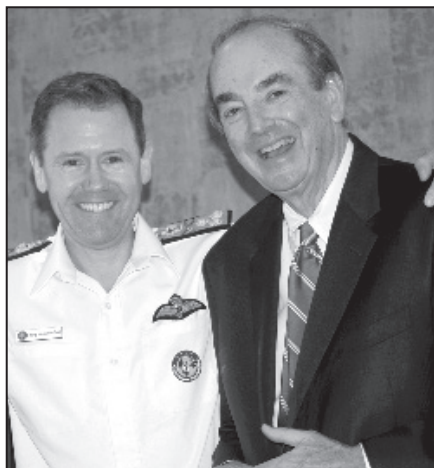

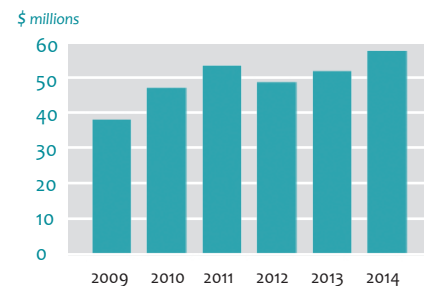
Virginia Wesleyan College completed the fiscal year on June 30, 2014 with revenues and transfers totaling \$56,853,055, expenses of \$56,503,119 and a net excess of revenues over expenses of \$349,936. Contributed revenue for 2013-2014 totaled \$5,746,681. Annual Fund gifts of \$1,285,584 totaled 22.37 percent of all contributed revenue. It continues to be a critical source of funds to meet operating needs and to fund annual scholarships, undergraduate research, study away experiences and faculty development programs as well as support the athletic programs of the College.

Virginia Wesleyan College's endowment value is affected by several factors each year, including investment returns, new contributions, and the annual payout for College programs, scholarships and professorships. The endowment generated an investment return of 15.89 percent for the fiscal year that ended June 30, 2014. It was valued at \$57,713,000, increasing from a market value of \$51,827,000 on June 30, 2013. In 2014, distributions from the endowment contributed 4.75 percent of the operating budget of the College.

(as of June 30)

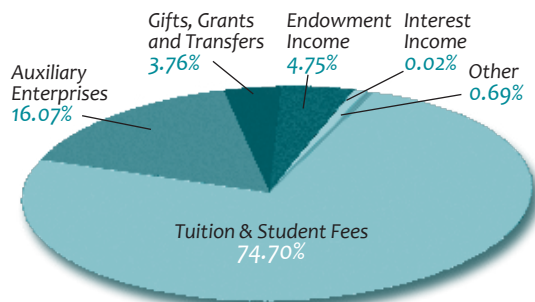

**OPERATING STATEMENT OF REVENUE AND EXPENDITURES** for the 12-month period ending June 30, 2014

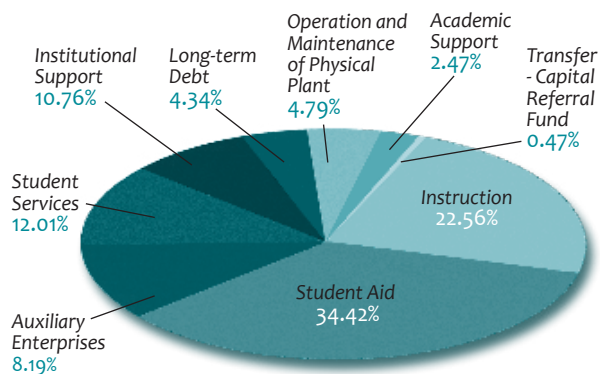

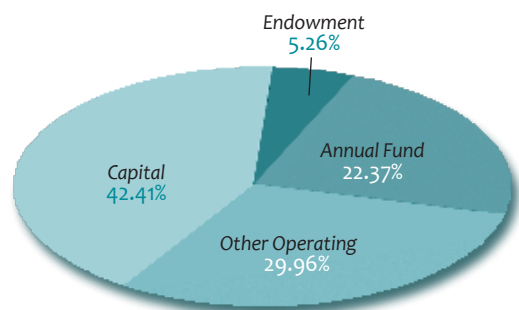
